Entered Employment (2nd quarter after exit)	Number of exiters employed during the 2nd quarter after exit (For youth only - numerator includes those employed or in education or training during Q2 after exit).
Entered Employment (4th quarter after exit)	Number of exiters employed during the 4th quarter after exit (For youth only - numerator includes those employed or in education or training during Q4 after exit).
Median Earnings	The midpoint of wages earned during the 2nd quarter after exit for all exiters with wages in the 2nd quarter after exit.
Credential Rate	Number of exiters enrolled in postsecondary education or training that obtained credential during participation or within 1 year after exit. OR Number of exiters enrolled in secondary education program and obtained secondary school diploma or equivalent during participation or within 1 year of exit AND were also employed or enrolled in education/training leading to a credential within 1 year after exit.
In-Program Skills Gain	Number of in-program participants in an education or training program that leads to a postsecondary credential or employment and are achieving skill gains in one of the following: 1. Educational Achievement 2. HS Diploma or equivalent 3. Secondary/post-secondary transcript/report card 4. Training milestone 5. Skills progression

1. Retention Rate with Same Employer	Number of participants employed with the same employer in Q2 and Q4 after exit.
2. Employer Penetration Rate (Market Penetration)	Number of establishments that have received, or who continues to receive, a service or other assistance during report period.
3. Repeat Business Customers Rate	Number of establishments that have received, or who continue to receive, a service or other assistance during report period AND who utilize a service anytime within previous 3 years.
