G. PUBLIC COMMENTS

The following public comments were received during the meeting:

-Magali Sanchez Paul, Program Manager for UCLA Institute for Research on Labor and Employment, grassroots directly to the residents, empowering the community through community engagement, looking to engage organizations that are directly connected to the community residents- believes outreach using CBOs should be reconsidered to include direct contact with community constituents to ensure solid partnerships.

-Kirk Kane, Executive Director RIO HONDO AJCC, recommends that the RFP be postponed for another year. Currently in capacity building year, most impactful factor has been two and a half years of pandemic operations, businesses paused or reduced services, clients are just now feeling comfortable utilizing AJCC services after pandemic. All major blocks have impacted AJCC system. -Dr. Larry Taylor asked what the marketing strategies are in place to inform the public. -Joseph Taylor, Regional Impact Officer of Goodwill of Southern California, commented on pay equity across providers and vendors, how is the Department of Economic Opportunity ensuring pay equity across all vendors ensuring enough staff to provide in-depth services for most vulnerable program participants.
